## 2. Product Family Identification

Product family: **F11**

Product description: Colored buckets and lids for nonfood applications printed with a steel handle.

Material(s): **Recycled PP (Polypropylene)**

## 3. Scope

This declaration applies exclusively to the above-mentioned product family supplied by Dijkstra Plastics B.V.

The declaration is based on the product formulation, intended manufacturing process, supplier documentation, raw material specifications and the PPWR Article 5 Risk Assessment forming part of the technical documentation maintained by Dijkstra Plastics B.V.

## 4. Declaration

Dijkstra Plastics B.V., as a supplier of packaging, declares that the above product family has been assessed against the applicable substance-related requirements of Regulation (EU) 2025/40 (PPWR).

The assessment demonstrates compliance with:

- *Article 5(1) – Minimization of substances of concern:* <sup>\*</sup>
  - Article 5(4) – Combined concentration limit for lead, cadmium, mercury and hexavalent chromium.
  - Article 5(5) – PFAS requirements (where applicable)
  - Commission Regulation (EU) 2024/3190 – BPA and other hazardous bisphenols (food contact products where applicable).
